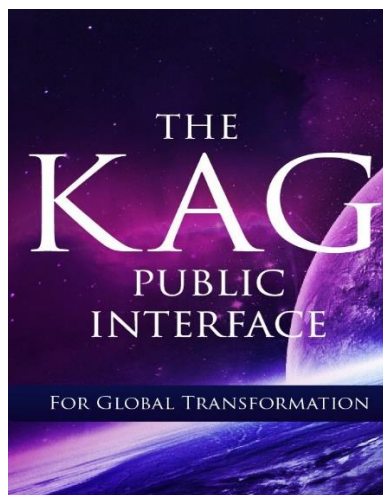

2. Via Company Shares

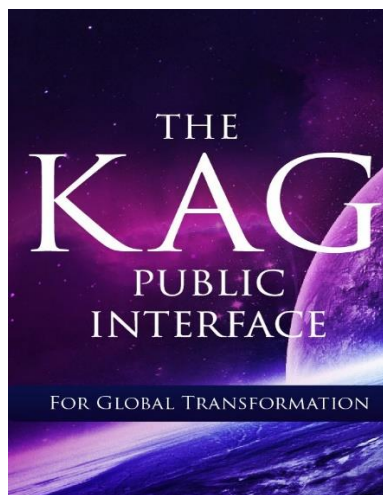

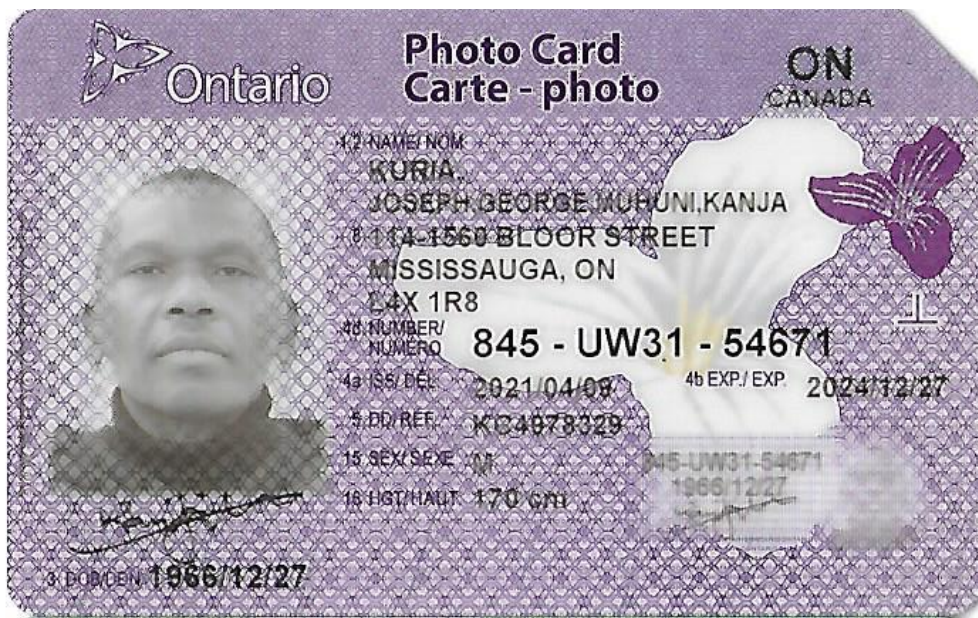

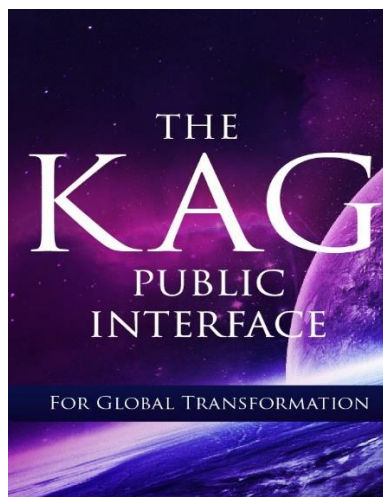

Back Face

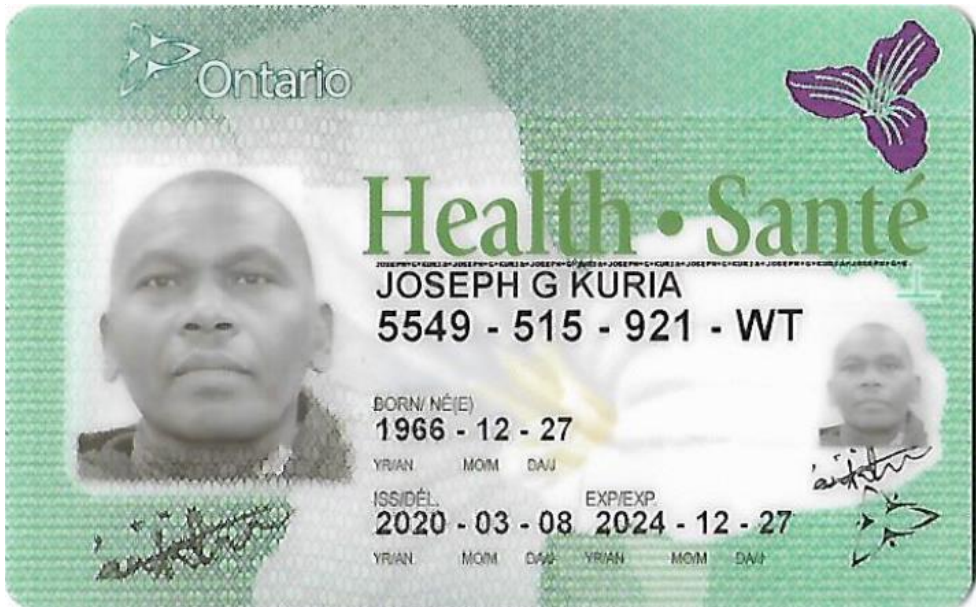
